LWCF Coalition Celebrates 3 Million Total Acres Protected by USFS Forest Legacy Program

Joins in Celebrating Quill Hill to Perham Stream Project and Lauds New Funding Opportunities

Lesley Kane Szyal, Chair of the LWCF Coalition, issued the following statement on behalf of the LWCF Coalition, additional quotes from LWCF Coalition Members and Partners are also below:

“Today is a landmark day in the history of the Land and Water Conservation Fund (LWCF) and the Forest Legacy Program (FLP). ([See the USDA press release here.](#))

First, we congratulate the many partners, elected officials, US Forest Service representatives and others celebrating the completion of the Quill Hill to Perham Stream project in Western Maine, which was supported by an allocation of nearly \$7.3 million from LWCF through the Forest Legacy Program. LWCF is the main funding source for FLP and was essential to ensuring this project’s success. Over its 33 year history, the LWCF-funded FLP has provided more than \$82 million to Maine, protecting over 750,000 acres.

Second, it is fitting – given Maine’s history with these programs – that Quill Hill to Perham Stream is the project that boosts the Forest Legacy Program to the [historic milestone of 3 million acres protected](#) throughout the US since the program began in 1990. Over \$1.1 billion in state, local, and private dollars has been almost equally matched from LWCF to make this achievement possible.

Third, we are thrilled that the US Forest Service announced significant investments, funded by LWCF and the Inflation Reduction Act, that will conserve more than 245,000 acres of some of the most economically and ecologically significant private forestlands across the nation, maintaining intact working forests while supporting local economies and driving natural climate solutions. This \$188 million investment, \$88 million from LWCF and \$100 million from the Inflation Reduction Act, is supporting 34 projects in 22 states and one island territory.

LWCF Coalition partners work tirelessly every day to protect and grow the legacy of LWCF and FLP - both important programs that enjoy wide, bipartisan support. Days like today only reinforce our commitment to protect special places and support communities throughout the US.”
